



COVID-19 WAIVER AND ACKNOWLEDGEMENT  
Summer Camp 2021

I hereby acknowledge that my child, \_\_\_\_\_ will be participating in a day camp program with the Barrie Dance Conservatory Inc during the summer 2021

I accept that the Barrie Dance Conservatory Inc (BDC) and its staff and volunteers will be taking all the necessary precautions and measures to ensure the safety of my child while in their care.

I am confident the staff will be following the guidelines provided by the health unit and the province of Ontario. These guidelines are as follows and may be updated from time to time. I understand I will be notified of any updates.

- an increase in cleaning throughout the day/week and of all commonly touched surfaces
- sanitization stations upon entering the building and throughout the facility
- temperatures will be taken upon entering the building
- outdoor shoes are to be removed immediately upon entering the building and coats will be hung on the hooks provided in the front foyer.
- frequent hand washing will be available and encouraged
- limiting the number of students in each program
- masks are to be worn by teachers, students and anyone entering the building (parents/volunteers) and while in common areas.
- masks can be removed by the students during class/camp time. If a teacher approaches a student to provide assistance and/or spotting he/she may be asked to put on their mask and both will sanitize accordingly.
- Students will bring their bags into the dance room with them along with water bottles. Lunch and snack breaks will be held upstairs in the dancers lounge.
- Parents of participants ages 5 and up are not allowed to enter the building. They must drop off and pick up at the front door.
- When packing snacks/lunch for day camp, please remind your child that they must take their garbage and recyclables home with them and they are not allowed to share their lunch.
- BDC keeps a daily list of participants and visitors who enter our building.
- Our safety plan is available at the front door.

I also understand that although BDC Inc and its staff will take all the necessary precautions to protect my child from exposure to the COVID-19 virus there are no assurances or guarantees that exposure will not occur.

I hereby acknowledge that as of today \_\_\_\_\_ my child and I have not been out of the country in the last 14 days, we have not been around anyone who has tested positive for COVID-19 and we don't experience any symptoms of the virus. I will have my child complete the self assessment link provided prior to each day of camp. I promise to provide you with any updates regarding the three main questions above and will inform BDC immediately if our situation has changed. BDC Inc and its staff will notify the health unit should a family, staff or volunteer report yes to any of the questions above. From there we will follow the direction of our health officials.
