Payment Policies:

- A \$50 deposit (non-refundable) is required to secure your registration (If taking full week). A 15\$ deposit/day if only joining a few days.
- The balance is due one week prior to the start date (April 5, 2021)
- Due to limited enrolment, if we do not receive the balance of your camp fee one week prior to the camp start date (April 5, 2021), you risk losing your spot.
- There is a 30\$ fee for chqs that are returned from the bank NSF
- The early registration discount is only valid to participants that are enrolled for the entire week.

Cancellations:

- Cancellations made one week prior to the camp start date will be refunded all fees minus the non refundable deposit(s)
- Cancellations made within a few days prior to the camp start date may be subject to a late notice cancellation fee of 25\$.
- Space is limited and we will have a wait list. Your cancellation on short notice could affect the ability for another child to join the camp week. Please be considerate and provide proper notice so that BDC can properly secure other registration in a timely manner.
- Refunds will not be given once the week has begun.

The Barrie Dance Conservatory reserves the right to close facilities, to change instructors, to cancel any activity with insufficient enrollment or to combine programs in which attendance falls below the minimum number required to run a program. We will notify you immediately of any such changes.

Program Removal:

I understand and agree that intentional participant behavior that puts the participant or others at physical or emotional risk may result in immediate dismissal from the program. Any expenses incurred because of program dismissal will be the responsibility of the participant / parent / guardian. Parents/guardians or a suitable designate must be available to pick up participants should the participant be dismissed from his / her program. Refunds will not be issued to students leaving a BDC program prior to the end of the session due to disciplinary action.
